FAST TIME STREAKER was hard to load then was sent to the front, set the pace then drew off heading into the far turn, was under strong urging then lugged in late stretch and bumped with REBEL ROCKET in late stretch and held sway in the end. TOP OF THE STONE chased the early pace while racing two wide on the backstretch, rallied on the far turn making a bid in the stretch but was second best. REBEL ROCKET chased the pace from the inside on the backstretch, made a bid in upper stretch along the inside then was bumped by FAST TIME STREAKER in late stretch and steadied losing his action and hung in the end. MUSIC MOGUL was allowed to settle while inside on the backstretch then failed to menace in the stretch. KRISTI'S UPGRADE was bumped on the first turn then raced two wide on the backstretch and was no threat. MY BUDDY TEX bore out on the first turn and was no menace. MOE D was unhurried early and failed to respond. SUPER VENTURE bore out on the first turn, bumped and steadied off heels then showed little and stopped in the stretch. IDE DON'T CARE chased the early pace, was through early and stopped. A STEWARD'S INQUIRY WAS HELD CONCERNING THE STRETCH DRIVE. A CLAIM OF FOUL WAS LODGED BY THE RIDER OF REBEL ROCKET AGAINST THE RIDER OF FAST TIME STREAKER FOR INTERFERENCE IN LATE STRETCH. AFTER REVIEWING THE FILM'S, THE STEWARD'S DISQUALIFIED FAST TIME STREAKER FROM FIRST AND PLACED HIM THIRD FOR INTERFERENCE IN LATE STRETCH.
