SWEETSOUTHERNMOON was settled while racing three wide on the backstretch, rallied four wide on the far turn, gained command then drew clear in mid stretch and was best in the end. IDEFROMTHEBAYOU was allowed to settle then rallied five wide on the far turn to upper stretch, was gaining ground in the stretch and was second best. GET IN DA HOUSE was allowed to settle while inside on the backstretch, rallied three wide in upper stretch making a bid but came up empty in the end. GO PUBLIC was two wide on the backstretch, rallied on the far turn making a bid while in a long drive but tired in the stretch. PERSONAL VELOCITY was unhurried early while racing on the inside down the backstretch, rallied two wide on the far turn but was no threat in the stretch. NOWANDFOREVERMORE was unhurried early then rallied and swung out to be six wide in upper stretch but was no menace in the stretch. SLIGO JOE dueled for the lead while two wide, was in a long drive while being used up and gave way. MR. PORTER was inside on the run down the backstretch then made a bid three wide into the far turn but was no factor in the stretch drive. CITY ORDINANCE dueled for the lead from the inside, was used up then stopped. TIZ BIZ was unruly in the starting gate then showed brief foot and stopped to be distanced in the stretch.
