YOUCANNOTBESERIOUS set pace while in a long drive, dug in gamely but weakened in late stretch but held the place safe. TEXAS COUNTRY DOLL was inside and settled, rallied in upper stretch and closed ground willingly in late stretch but was too late for the place. LILLIE ABBIE rallied three wide on the turn making a bid but was no menace in the stretch. SHAWNEE'S KELA raced three wide on the turn then made a bid but came up empty in late stretch. RUNNING SHOES raced three wide on the turn then failed to menace in the stretch. ESTHER CARL was unhurried early then swung out five wide in upper stretch but was no menace. LAWYER TIFFANY raced two wide on the turn then failed to respond. MISS NOON BY DOON chased the pace while racing two wide, was used up then gave way. MY THREE GIRLS raced three wide on the turn then faltered.
