CAN'TOUCHTHISGAL was settled while racing three wide on the backstretch, rallied on the far turn then was in a strong drive and proved best in the end. WALK AWAY RULER was allowed to settled then rallied three wide into the far turn, made a bid two wide to upper stretch but was no match in late stretch for the winner. MIS AVIE was allowed to settled then rallied four wide on the far turn making a bid then flattened out in the stretch drive. SENT was inside on the first turn then forced to check up off heels, dropped back on the run down the backstretch then rallied three wide on the far turn then was in tight just before the top of the stretch and forced to steadied again, made a mild rally in the stretch but was no threat. FRESH dueled for the lead while inside then drew off on the backstretch, was used up then gave way on the far turn. G G'S GIRL was unhurried early then rallied four wide on the far turn but failed to menace. MARKED TIME dueled for the early lead while two wide, was used up and stopped. DA BLAZ N BELLS chased the pace while racing two wide on the backstretch, made a bid into the far turn but stopped in the stretch.
