CAJUN CHARLIE set a well rated pace on the backstretch, drew clear in upper stretch and was clearly much the best in the end. FREDDIE ONE BITE was allowed to settle then raced on the inside on the run down the backstretch, rallied on the far turn while three wide, was still three wide in upper stretch then was gaining ground to be second best. VALIDFROMTHEGITGO was three wide on the first turn then made a mild rally while four wide in upper stretch but was no menace in the end. TOP CAT BOOGIE chased the pace while racing three wide on the backstretch, made a bid to upper stretch then came up empty in the drive. NOBLE ALEX was stalking the pace while racing four wide on the backstretch then failed to menace. ZIP MOTION was allowed to settle then rallied four wide on the far turn making a bid then flattened out in late stretch. JOE'S NO SAINT was allowed to settle while inside then failed to respond. PRINCE KADEN was outrun. PRIVATE PRAYER was unhurried early early and was no threat. PORTO POTTEA was unhurried early and no factor throughout.
