INY BELLE exchanged bumps at the start, raced within contention and drove clear late. GRAND DESIRE vied for the early lead, saved ground around the turn, proved no match late for the winner, but was clearly second. FLUFFY FEELING unhurried in the early part, made a late bid, but was no match for the top two. RUTHY RED dueled for the early lead and weakened late. EXCAVATRESS lacked early speed, moved up, but was no factor. HATENOT raced near the back in the beginning, moved up, but was no threat. BABY B COOL raced in the middle of the pack, saved ground around the turn and faded. BLUFFIN RAIL raced within striking distance, came around the turn on the outside and was done early. OPAL'S GHOST always raced near the back and showed little. PERFECT LIL exchanged bumps at the start, raced in the back and was never a threat.
