DRIFTING WIND set a pressured pace while racing two wide, was in hand on the far turn while still in control, was roused in upper stretch and held sway in late stretch. MARKET ICE was allowed to settle in the early going while inside, saved ground on the far turn then made a bid two wide in mid stretch, was gaining ground but was unable to get past the winner in late stretch. STEALTH HERO stalked the pace while racing three wide then dropped back entering the far turn, came again in the stretch drive and finished well in the end. BONESINABOX pressed the pace while racing on the inside, gained the lead on the backstretch while being hard used then faltered in late stretch. MY BELL BOY raced four wide on the backstretch then made a bid on the far turn but came up empty in late stretch. YUKON BANDIT broke out at the start and bumped hard, raced two wide on the backstretch then failed to respond when asked. KEEP THE MONEY was pinched back at the start then was unhurried early, failed to menace in the stretch. GASTON raced five wide on the backstretch but was no factor. PART OF MY FAMILY was allowed to settle then failed to mount a rally. POWER SURGE raced six wide on the backstretch and was no factor.
