LOUISIANA VAL was inside on the run down the backstretch then made a bid two wide on the far turn but was no menace in the stretch. CAJUN ROYALE was three wide on the backstretch then failed to menace. PRIMARY SOLDIER was hustled along to move up and pressed the pace while two wide on the first turn, was used up then stopped on the far turn. A claim of foul was lodged by the rider of PRINCESS MAYA against the rider of LUCILLEVILLE for interference on the second turn. After reviewing the films, no action was taken.
