JUDITH GENE was settled then rallied strongly four wide on the turn, powered up to the front in the middle of the turn and drew off in mid stretch and was clearly best. BOOGIE N AGAIN was settled then squeezed back behind JUDITH GENE and IMPULSIVE BET going into the turn, rallied four wide on the turn, was gaining ground but was second best in the end. BOOK OF BUSINESS set the early pace, was used up then gave way on the turn. WALDO GIRL raced three wide into the turn, made a strong bid to upper stretch but came empty in late stretch. BAYOU JILL was settled then rallied three wide entering the turn, was between rivals then pin balled between IMPULSIVE BET and SHES BRUTAL, made a mild gain but was no threat. IONA chased the early pace while inside, was used up and weakened. SHES BRUTAL Chased the early pace while two wide, was bumped on the turn then faltered in the stretch. IMPULSIVE BET was unhurried early then raced four wide on the turn, was bumped hard then faltered in the stretch drive. A claim of foul was lodged by the rider of BOOGIE N AGAIN against the rider of JUDITH GENE for interference heading into the turn, After reviewing the films, no action was taken.
