Footnotes

SCREAMING set the early pace then drew off entering the far turn, bore out in upper stretch then drifted out in the stretch drive and was in a strong drive to hold sway in the end. MADAM DREAM was allowed to settle then rallied five wide coming out of the far turn, was closing ground willingly in late stretch to be second best in the end. SHE CAN BOOK was stalking the pace while racing three wide, rallied on the far turn and upper stretch, was carried out in late stretch and hung in the final seventy yards. FAVRETTE was allowed to settle then saved ground on the far turn making a bid but was no menace. NO BID KIP chased the early pace while two wide, rallied on the far turn then was carried out in the stretch but tired in late stretch. ANGEL OF FIRE was unhurried early then made a mild rally while three wide and gained some ground in the stretch. U DARE ME chased the pace while racing four wide, was used up and faltered. CECELIA'S AURA was inside on the backstretch and was no menace. SWEET AND YOE was unhurried early and was no factor. FLAMINGSPICEGIRL trailed throughout. A claim of foul was lodged by the riders of SHE CAN BOOK and NO BID KIP against the rider of SCREAMING for interference in the stretch. After reviewing the films, no action was taken.
