### Footnotes

PRINCE OF APRIL broke a step slow, racing near the back, moved up, three wide around the second turn and drove clear late. HEARTOFTHEMISSON vied for the early advantage, took the lead around the final turn, was outfinished for the win, but held on for second. DAILY MIRACLE had an awkward start, racing in the back, moved up, four wide around the final turn, rallied and missed place. KELA'S CAJUN raced in the middle of the field, made a mild bid, but was no factor. JULIE'S WARRIOR vied for the early lead and weakened. UNCLE BOOTY raced near the middle of the pack and lacked a bid. OVERNIGHT FLIGHT dueled for the early lead, saved ground around the final turn and faded. ELLENS BOY broke slow, raced in the back, had a wide trip and was never close. DUENO broke slow and was never close. JUSMOVE raced within contention, came around the final turn five wide and dropped back.
