GLORIOUS STRIKE was allowed to settle in the early going, rallied two wide entering the far turn, powered to the front in mid stretch and drew off in late stretch. JUMP JUMP was allowed to settle then rallied two wide heading into the far turn, gained command then was in a hard drive but weakened and was second best in the end. FRIEND OF INDY was allowed to settle then rallied three wide on the far turn but was no threat in the stretch. SAINT FLOYD was allowed to settle then rallied four wide on the far turn then failed to menace in the stretch. WHY SEVENTEEN was unhurried early then raced two wide on the far turn but was no threat. LOW PLACES was allowed to settle then failed to menace. PURELY AWESOME was unhurried early and was no factor. ROGIYA showed good early speed and set the pace, drew off on the first turn but was used up and stopped on the far turn.
