MIRROR BAY was inside on the backstretch, was settled then rallied along the inside the far turn, slipped through the inside in late stretch and was up in the final stride. A RUNNIN DREAM dueled for the lead while two wide, was in a long drive then drew off on the far turn, was all out in late stretch but was caught in the final strides. ZEALUNAR was allowed to settled then raced two wide into the far turn, was checked slightly on the far turn, moved out to four wide of the stretch drive and finished well in the end. LOUISIANA LIGHT was allowed to settled then rallied on the far turn while three wide but was outfinished in late stretch. TRIBUTE'S PASSION was unhurried early then rallied and swung out to be four wide in upper stretch but was no menace in the end. SWEET TEXAS STAR was unhurried early then rallied and swung out to be eight wide in upper stretch but was no threat. ROLL PRESLEE ROLL was unhurried early then rallied five wide on the far turn but was no menace. SET PLANS was unhurried early then rallied four wide on the far turn but was no menace. R U'S GOLDEN LADY dueled for the lead while inside, was in a long drive then weakened in the stretch drive. SHAKEM N BREAKEM stalked the early pace while racing four wide on the backstretch, was used up and gave way. A claim of foul was lodged by the rider of ZEALUNAR against the rider of MIRROR BAY for interference on the far turn. After reviewing the films, no action was taken.
