LANE CHANGER was unhurried early and kept to the inside, rallied entering the far turn moved out to be two wide then closed fast on the outside and caught FRONT LINE LAWYER in the final strides. FRONT LINE LAWYER was settled along the inside on the run down the backstretch, made a quick move heading into the far turn to take command then drew clear in the middle of the turn, was in a hand drive and was caught at the wire. BOUND FOR GLORY was unhurried early then rallied four wide on the far turn, made a bid then flattened out in late stretch. THISISAFASTMAN was allowed to settled then rallied along the inside on the far turn making a bid but was no menace in the stretch. LITTLEMUDDYJACK was allowed to settled then failed to menace. A. P. JOE set the early pace, was used up on the backstretch then gave way on the far turn. ALLISON'S PAL was allowed to settled on the backstretch while racing four wide then faltered in the drive. MARGOS SOUTHERNBOY was unhurried early and was no menace. GALLOPIN GATOR chased the early pace while three wide, stopped badly on the far turn, bobbed at the top of the stretch and was pulled up by the rider appearing lame and was van off.
