### Footnotes

LEMON SHERBERT was well placed while racing two wide, dueled for the lead while two wide, was in a long drive and proved best in the end. DORSEY'S DREAM was allowed to settled then rallied thee wide on the far turn, made a bid but came up empty in the final strides. REBEL SKY dueled for the lead while inside, was in a long drive then gamely dug in throughout the stretch but hung in late stretch. K ONE FOUR was unhurried early then rallied four wide on the far turn, made a mild gain in the stretch. ROYAL AND FLASHY was unhurried early then rallied two wide on the far turn making a bid then flattened out in the drive. PRADO'S MAIN MAN was unhurried early and inside, saved ground on the far turn but was no menace in the stretch. JUMP IN LINE was three wide on the backstretch then faltered. WHY SEVENTEEN was through after a half then stopped. SPECTACULAR BOB was through after a half and stopped.
