SILVER SPECIAL was settled while inside into the far turn, rallied and angled out three wide in upper stretch, quickly drew clear in late stretch and was much the best. FOXY APPEAL chased the pace while racing two wide, rallied on the far turn two wide to gain a slim lead then was no match for the winner in the stretch. OBJECTIVE LADY set the pace then drew off on the backstretch, was used up and faltered in the stretch drive. SLEET'S APRIL ROSE was unhurried early then raced on the inside on the far turn making a bid then flattened out in the stretch drive. CASCADING KATEE was allowed to settled then failed to menace. PERUVIAN PRINCESS was unhurried early and was no factor. TRAVIS PEAK was no threat. ROARING GOLD was through after a half then stopped. BYARS BODGIT was through after a half then bolted entering the far turn and stopped in the stretch.
