CASH ARRANGEMENT vied for the early lead while two wide, duelled on the turn while two wide then drew off in mid stretch then held sway in the end. STORMY DEVOTION was unhurried early then saved ground on the turn, rallied two wide in upper stretch and closed fast in late stretch but was too late. COLTON'S HOPE was unhurried early then rallied on the turn while five wide, was gaining ground on the outside and gained the show in the end. SUSPECT SARA was unhurried early then rallied on the turn while two wide, made a bid but was outfinished in the end. DIXIE SWEETHEART duelled for the lead while inside on the turn, was in a long drive then weakened in the stretch. CHOCKLATE PIE vied for the early lead while three wide, was used up and gave way. HIGHGEARTOWN vied for the early lead while four wide, was hard used then faltered. PRIMARY SOLDIER chased the early pace while racing three wide into the turn then gave way. CAJUNS GAME chased brief speed while four wide and stopped. FLOWING TIGRESS bore out on the turn and was pulled by by the rider in late stretch and walked off.
