CACTUS MAX broke sharp from the outside, gained a clear early margin entering the first turn, remained clear up the backstretch, continued to be clear entering the second turn, drifted out entering the drive bothering PEYTONAIDANNBELLA, remained clear at the eighth pole then was all out to last late. After a Jockey's Objection CACTUS MAX was disqualified for interference entering the stretch. PEYTONAIDANNBELLA up close early from the outside, remained forward up the backstretch, continued to forced the issue entering the second turn, was forced wide when the winner drifted out, recovered to respond but just missed. UBETA HOPE stalked the early pace from the outside, crept closer entering the second turn, was forced seven wide into the drive, recovered and was gaining late. KING OF SMILES well placed from the inside, altered outside entering the second turn, responded and finished well but too late. DIABLO ACT pressed the early pace from the inside, dropped back entering the drive, responded to come again but was too late. JOHN ETBAUER up close early from the outside, tired in the drive. SOUTH WEST TARGET could only pass tired ones. E Z VIEW forced the early pace from the inside and tired. MR. JOHN K. had a steady fade. PAULTHATSALL trailed throughout.
