Footnotes

FRENCH MOON settled just off the pace toward mid track, edged closer through the turn, raced at even terms three wide nearing the quarter pole, dueled clear midstretch and widened under steady handling. COURTING WISDOM exchanged contact with DIRT DIVER leaving the gate, rated close about the three path, steadied nearing the turn, eased six wide into the stretch and closed for a late place. RADIUM SPRINGS rated with the pace while alternating for early control, gave chase nearing the turn, angled out entering the stretch then outfinished for place at the wire. NEVILL'S MISTAKE stalked the pace two deep, contested a slight advantage through the turn and remained a close factor to midstretch before weakening. QUAD'S DOUBLE settled off the pace about the three path, made a mild bid angling outward on the final turn, entered the stretch widest and finished evenly. DIRT DIVER exchanged light contact with Courting Wisdom leaving the gate, rated with the pace inside then weakened in midstretch. VALUE YOUR ANGEL was outrun. READ MY TALE's rider raced without his irons the opening quarter mile and never factored. STORMY PRINCE was outrun. FULL RATE quickly dropped back. RAMBLIN ROMEO was not a factor. The stewards reviewed a claim of foul against the winning rider, lodged by the rider of Courting Wisdom, but found no reason for change.
