### Footnotes

SLADEN K bobbed at the start and veered in then vied for the lead racing three wide and drove clear in the final furlong. FLASHY BULLET was pinched back at the start and steadied then responded well in the drive. DAYLIGHT AFFAIR dueled for the lead along the inside then faded in the final furlong. IMPULSE PURCHASE stumbled at the start then failed to be a threat. SAINT ABE showed little. DIAMOND COUNTY dueled for the early lead between horses, bore out sharply around the turn and continued wide in the drive. GIB tired. A claim of foul by the rider of FLASHY BULLET against the winner for interference at the start was not allowed following a stewards inquiry.
