**Footnotes**

QUEEN OF THE TURF made a quick move to challenge for and gain the lead out of the second turn, drew off to mid stretch then prevailed late under brisk handling. TOP TIME made a three wide middle move, angled inside in upper stretch then was gaining late inside. STRONG VOWS was unhurried early then angled to the middle of the course and closed a gap but too late. PAGES LANE made a middle move to the stretch but failed to sustain that bid. JEUX DE DANSE dueled for six furlongs then gave way. LADY MONARCHOS turned in a dull effort. GOLDEN FEMME chased inside but came up empty. CHEETAH'S CHROME was through after a half. DREAMLINER was used up. SPINDLETOP was through early.
