EXCLUSIVE WARRIOR dueled into the stretch, shook clear while well off the inner rail, drifted to the inside in the furlong grounds then shook clear again late. M'S ANGEL stalked the pace, bid inside into the furlong grounds, angled back to the middle of the track into the final furlong then weakened. ASSIGNATION was void of speed to the stretch then lodged a mild bid late. CAYMAN ISLANDS raced evenly. ESPRESSO MARTINI set a fast early pace then faltered. PI SQUARED stopped. A claim of foul by the rider of MR. ANGEL against the winner for interference in the stretch was disallowed.
