

ANCLOTE moved up menacingly with a three wide bid to challenge entering the far turn, gained the lead in the final furlong and edged clear late. LIL PUNKINDO disputed the pace two wide, couldn't withstand the winner in the final furlong and remained clear for the place. URBAN DANCER ducked out at the start, saved ground disputing the pace and faded in the final furlong. CHANGEABLE, unhurried early, lacked a sufficient rally. OVERRIDE stalked the pace to the far turn then had little response when called upon. COMPANY STORM tired.
