HASTA LUEGO made a middle move closed willingly late inside to just miss. SLIP AND DRIVE was hung wide from the second turn to the wire then was just outkicked in a game effort. TIME FOR TUTT dueled to deep stretch before just hanging. ROCKABY BAY was well placed into the final furlong but was outkicked. JACK ARMSTRONG dueled to late then weakened. MOVING WEST failed to menace. SHOOKSTOWN ROAD weakened gradually. RAGING LION was well placed to the quarter pole then came up empty. SUPER DOC trailed.
