HAPPY BULL stalked the pace in hand, took over outside the leader into the stretch then drew off to win in impressive fashion. CUDJO made a middle move into the stretch then was up for the place. SMILEY PETE stalked the pace inside, swung outside into the stretch then failed to respond. SNUCKINTHEFOREST set a quick pace into the stretch then gave way in the final furlong. MR. COMMISSIONER was rallying mildly into the stretch when shut off by SMILEY PETE. CHARLEY'S DIAMOND showed little. Following an objection by the rider of MR COMMISSIONER, SMILEY PETE was disqualified and placed fifth.
