BROKERAGE HOUSE stalked the pace along the inside, awaited room around the far turn then moved through between rivals in the drive and won under strong handling. DR RICO, unhurried early, finished gamely along the inside to get up for second. MY SON SPIDER was unhurried early then responded well in the drive to get up for third. DOUBLE DOORS (GB) matched strides racing two abreast and gave way grudgingly. MABOU was pinched back at the start then responded well in the drive. CHALUIWITCANE, forwardly placed, lacked the needed rally. DIXIE DECISION, forwardly placed, lacked a rally. MY CRUSADER tired. QUITE ACCEPTABLE moved to the inside when clear early to dispute the pace then tired.
