CREW was well placed racing close up along the inside and finished willingly. NOT ABROAD moved closer leaving the far turn then went evenly in the stretch. PUNSTER was unhurried early then failed to threaten. WILL'S AFLEET lacked a solid rally. COMMANDER matched strides outside the leader for six furlongs then weakened.
