ELECTRICAL CARLITA quickly went to the front to control the issue and drew off to prove clearly best in handy fashion. WILD BERRY was checked when shuffled back lacking room inside the winner approaching the half mile pole then continued well to hold second. PROSPECTIVE GLOW was prominent from the outset and easily best of the others in the stretch. ROYAL MAGICIAN lacked a rally. PLEASANT PASTURES broke a step slowly then failed to menace. PAT'S POSSIBILITY had little left for the drive. A claim of foul by the rider of WILD BERRY against the winner for interference on the backstretch was not allowed following a stewards inquiry.
