BLAZEN, unhurried early while racing along the inside, rallied to challenge in the final furlong then drove clear. LANSDOWN STREET prompted the pace then shook loose in upper stretch but was not quite good enough. TWISTED DREAM, well placed just off the pace, lacked the needed closing response. COFFEE CAKE, well placed along inside, was pushed out in the final furlong and finished willingly. GOOD ENDING circled rivals into the stretch and finished well. SMALT was forwardly placed to the stretch then faded in the drive. RAFFERTY raced within striking distance for six furlongs then weakened. SNAKE EATER broke a step slowly then was outrun. MOJAVE MIRAGE tired. PETTARANO saved ground disputing the pace then tired. CHASE MY HEELS showed little. AMIGO MIO tired.
