I'VE GOT SPEED chased the leader from the outset, bid outside that one after five furlongs then was fully extended to prevail over MR. NOTEBOOK after a long stretch duel. MR NOTEBOOK was away alertly, set a slow pace under good handling then resisted gamely when challenged and just hung late. LORD LOUIS fanned four wide into the stretch, loomed a threat outside in the furlong grounds but was outkicked late. KING'S CORONATION closed a gap too late. COTTAGE (ARG) saved ground, was within striking distance into the stretch then wasn't strongly handled after bobbling twice in the stretch. BETNOW failed to threaten. CAMPFIRE BURNING stopped.
