Footnotes

GRUNDLEFOOT was squeezed and bumped at the break by SNUCK IN to race off the pace for more than six furlongs, swung five wide for the drive then ran down the leaders in the late stages. PERFECT CAT was boxed and steadied from the three eighths pole to mid stretch, exchanged bumps with BIG E E in the drive then came out from behind SNUCK IN late to be up for the place. MERCALDO made a four wide middle move, loomed boldly outside rivals through the furlong grounds then hung late. SNUCK IN came in to bump rivals at the start, dueled to mid stretch then weakened. PICKUPSPEED was off slow then closed a gap late. BIG E E pressed the pace three wide to near the furlong marker then exchanged bumps with PERFECT CAT before being pushed out a bit by that one while tiring late. LIGHTNING PACES was knocked off stride at the start when GRUNDLEFOOT was pushed into him, dueled to near mid stretch before giving way. PAINTED PISTOL failed to menace. A claim of foul by the rider of BIG E E against PERFECT CAT for interference during the stretch drive was disallowed.
