ELECTRICAL CARLITA broke alertly to show the way to the furlong grounds then wasn't good enough and gave way. WALLOP raced within easy striking distance and finished evenly. BORDER BOUND pressed the leader two abreast and weakened in the drive. GLITTERING RACKET prompted the early pace and tired. WIRED N READY showed little.
