STORM FLITE quickly went to the front to set all the pace and held SARACANDU safe under steady handling. SARACANDU prompted the pace from the outset, lacked the needed closing response and held on well in the drive. MISS EVENT moved up wide on the turn then finished best of the others. REEL CONVICTION was outrun early then rallied mildly outside rivals. DUSTY'S GONE prompted the pace to the stretch then faded in the drive. PLEASANT PASSAGE moved up menacingly leaving the turn then flattened out in the drive. PLEASURE PRO failed to threaten. CRYPTO'S VIEW showed little. PAM'S THUNDER tired from her early effort. PLATINUM RECORD broke through before the start, showed early speed along the inside then tired. CAN I tired. WINGINIT showed little.
