MYERSROCKS chased the winner from the outset and lacked the needed closing response. HELLO D. NGATA rallied mildly between horses to get up late for third. SKIP THE TRIAL dueled for the early lead along the inside rail and faded in the drive. DALAMAR showed speed to the stretch then weakened in the drive. G MAN JOE showed little. MCSUAVE tired. DIAMOND COUNTY showed little.
