JOYOUS JESTER, well placed just off the pace, was under strong handling to run down the leader in deep stretch. LEMON SKY stalked the pace, moved to the lead approaching the far turn then fought it out gamely to the end. OWEN MEANY moved closer around the far turn then held on gamely for third.

RIKIM, away alertly and forwardly placed, responded well in the drive. KENTUCKY WARRIOR broke slowly, was unhurried early then finished willingly. MORE COWBELL failed to seriously menace with a mild rally. BRUNO'S A BITER prompted the pace then lacked the needed response in the stretch. TRI POWER was forwardly placed then faded in the drive. CHANGING FUNDS lacked a rally. EDITOR'S COLUMN broke slowly then was outrun. LONGTIMENOSEE showed little. TARA'S WARRIOR saved ground setting the early pace then faltered.
