GIANT MOVE raced well placed early, bid outside the winner into the stretch then shook free and drew off late. CIRCUMVENTOR broke alertly, set a slow early pace but was no match for the winner while besting the rest. BAREFOOT LANDING made a middle move but failed to sustain that rally. ALBANY ROAD was well placed but had no rally. MAX HAZARD steadied along inside into the backstretch then continued to steady along advancing along the rail but had no rally. MALA MALA CAT chased off the rail then faded. TONY'S BACK was well placed but came up empty. FIVE GUNS WEST showed little. DONTGETGLADGETMAD was through early. ITALIAN GAMBLER stopped. RICHIE RULES was no factor. A claim of foul by the rider of MAX HAZARD against the winner for interference into the backstretch was disallowed.
