RINKA DINK SWAP dueled inside and was eased back leaving the backstretch then lacked the needed stretch response. RIZMON moved up menacingly on the turn then faded in the drive. CALLING ANGELS failed to menace with a mild rally. VALS A DOCTOR prompted the early pace and weakened in the drive. PLATINUM RECORD lacked a rally. PLEASURE PRO showed little. CASEY DARLING was outrun.
