Footnotes

SETTLING FOR GOLD saved ground early, swung out on the far turn to advance then closed to run down the leader in the final furlong and won going away. DUNLIN broke sharp, saved ground setting the pace then was not good enough for the winner. LOOKS LIKE SIS was checked on heels between rivals into the far turn then continued willingly. CROSS MOUNTAIN moved up menacingly outside rivals on the far turn then needed more in the drive. TUOUBLIERASMONNOM was unhurried early then failed to menace with a mild, late bid. MINE'R YOURS was forwardly placed along the inside rail then weakened in the drive. GROOM'S TRIAL prompted the pace then weakened. ASSIGNATION showed little. ATLANTIC TIDE prompted the pace for six furlongs then had little left. DISTORTEDREDHEAD tired.
