Footnotes

LIGHT DANCER chased the early leaders, bid four wide after a half, came in into the second turn then drew off late under brisk handling. WAITING TIME made a four wide middle move, couldn't threaten the winner but outfinished the rest for the place. GO BABY GO (IRE) showed no speed to be outrun for six furlongs, fanned seven wide into the stretch then was gaining ground outside late. COMPANY STORM pressed the early pace, steadied inside the winner into the second turn then failed to gain in the late stages. RIZZI GIRL made a wide middle move through the second turn but failed to sustain that rally. ATRIAL FLUTTER showed no speed and was no factor. SECRET MYSTIQUE pressed the pace to the second turn then gave way. AUNT LOUISE raced close up to the quarter pole then faded. MEDIA ACCESS was rank inside racing close up for five furlongs then gave way. HAZINO stopped after six furlongs. A claim of foul by the rider of COMPANY STORM against the winner for interference into the second turn was disallowed. The portable inner rail was set out 25 feet.
