**Footnotes**

GODMOTHER came in at the break to bump TIME TO DREAM and force her to the inside, stalked the pace to mid stretch then wore down the leader to be along in time. TIME TO DREAM was bumped and forced in at the start by GODMOTHER, dueled for a half before drawing clear then hung late while saving the place. DREAM FOR A MOMENT was void of early speed, got through inside into the stretch then angled off the rail leaving the furlong marker and was gaining late. ELEKTRALINE was bumped at the start, pressed the pace inside to the stretch then weakened in the final furlong. COTTAGE GARDEN showed little. VALARONE was bumped at the start, chased the leader for a half and stopped. A claim of foul by the rider of TIME TO DREAM against the winner for interference at the start was disallowed.
