ETERNAL MISS broke alertly, saved ground setting the pace and gave way grudgingly. ZIP CITY DANCER prompted the pace racing three wide and weakened under pressure. SOUTH ISLAND, away in good order, lacked the needed rally. HURRYCAIN JOAN pressed the pace to the final furlong then weakened. SUPER MIRACLE lacked a rally. ENGIN FIZZ failed to threaten. BUBBIE'S LOVE tired. UPTITEANNI ran off in the post parade then showed little in the running. MINER'S MONSTER was outrun. EXPRESSIVE STAR showed little.
