WRONG DELIVERY, unhurried early, advanced three wide after three furlongs, shook off the leaders leaving the furlong marker without need of urging and won in handy fashion. UTAH GOLD raced wide much of the trip and was up for second while no threat to the winner. V FOR VERA dueled inside to mid stretch before weakening. J D'S BEST SELLER fanned wide leaving the turn but made up minor ground. LIP SING'S AFFAIR dueled outside V FOR VERA to mid stretch before fading. THREE MILE RUNNER failed to threaten. SCYTHIA turned in a dull effort. BLUSHING CALLER chased the leaders early, drifted through the turn and faded. SPLASHING ROSE showed little.
