### Footnotes

TRUMAN'S COMMANDER was unhurried early then moved closer around the far turn and closed determinedly between rivals under strong handling. I. E. FLASH prompted the pace, moved to the lead with a three wide bid on the far turn then fought it out gamely. CAFE DES ARTISTES saved ground early, moved out to advance around rivals on the far turn then closed gamely. COMPATRIOT moved up along the inside on the far turn then lacked the needed closing bid. ARIDUS rallied mildly outside rivals through the stretch. SHANGHAI DADDY lacked a rally. MY BOY JIMMY tired. FRANCESCO PUNCH was checked between rivals into the first turn, moved up to prompt the pace then tired. MIKE THE LEADER saved ground setting the early pace then tired.
