OWEN MEANY bumped with IDENTICAL while circling rivals completing six furlongs to challenge for the lead, drew clear then held the latter safe. IDENTICAL bumped with winner while trying to force his way out completing six furlongs then continued well in the drive. BREEZY TRIP saved ground disputing the pace and weakened in the drive. OUT TO PLEASE was unhurried early then failed to threaten. CHANGING FUNDS lacked a rally. RANGER CREEK disputed the pace racing two wide then had nothing left for the drive. NEED TO PROSPER was through early. A claim of foul by the rider of IDENTICAL against the winner for interference on the far turn was not allowed following a stewards inquiry.
