MERRY BERRY was void of early speed, looped rivals five wide moving to contention then rallied down the middle of the track to be up in time. UNYIELDING TIME made a three wide middle move, challenged outside the leader in the furlong grounds then drew even late before just hanging. MINERS DREAM chased early, challenged after five furlongs, shook clear in the drive then also just hung. COVER UR HEART raced close up early, bid leaving the second turn then weakened in the drive. BELLA JOLIE raced evenly. MISS SWEET N SOUR failed to menace. GOJI GIRL set a moderate pace then gave way. MY SWEET THUNDER was through after a half. TRIPLE TEASE stopped and was outdistanced.
