Footnotes

WESTERN PIRATE looped rivals through the turn, bid five wide in the drive then drifted in while going to the lead in mid stretch and drew off late. FUNNY BOOK stalked the pace early, bid into the stretch then was put in tight quarters when WESTERN PIRATE drifted in during the stretch and was forced to steady before besting the rest. TUCKLINO lodged a belated bid outside late. THE BOILER pressed the pace early, drew even into the stretch then gave way in the final furlong. PLEASANT failed to menace. EDDIE MUNSTA dueled to mid stretch then gave way. NO VOW BROKEN trailed. Following a stewards inquiry and claim of foul by the rider of FUNNY BOOK, WESTERN PIRATE was disqualified and placed second for interference in the stretch.
