LOVE THOSE BOOTS disputed the pace racing two abreast and fought it out gamely to the end. LEMON JUICE moved closer into the stretch then ran down rival in time for third. AVENUESOFNEWYORK, well placed close to the pace, lacked the needed closing kick. FRESHY FRANCESCO responded well in the drive but was too late. DISTINCTLY DONOVAN failed to threaten. ALL TRIPPED UP dueled for the lead then tired. HOT SPEED pressed the early pace then tired.
