R VICARIOUS GIRL chased inside, got through along the rail in the drive to challenge but couldn't stay with the winner while outfinishing the rest. INCLINED TO DREAM made a middle move then rallied outside in the drive but was outkicked. DREAMING OF SASHA closed a gap too late. CAT N CABOODLE was well placed but had no rally. KINDA KATTY was also well placed but gave way after six furlongs. OVERLOOK set a slow pace into the final furlong then faltered. RACYN WITH GRACYN was through early. ROBIN DES CONCORDE showed little.
