HYPERLINK raced close up early, bid after five furlongs to gain a short lead but hung late while besting the rest. VEUVE set a solid pace but weakened in the final furlong. REPREIVE lodged a belated rally. MONTEREY STREET pressed the pace to the second turn then faded. LUNCH MONEY failed to menace. CAKE WALK stopped.
