GET IT ON led early, held on well when displaced on the lead then came back on again after six furlongs to duel through a long drive and get up late. LUCKY LADY LAWYER was rank early and pulled his way to the lead into the backstretch, set a slow pace under rating then resisted through a long drive before just hanging late. PENNY'S CHIME raced close up three wide much of the way but weakened in the drive. TREAT TO SUCCESS passed tiring rival. FOUNDATION raced evenly. LOCO SWEET was taken up from between rivals after the start. WILL UNBRIDLED showed little.
